# BREAK AWAY FROM LEGACY SYSTEMS WITH FLEXIBLE DEPLOYMENT OPTIONS

Some HHS agencies are still tied to aging, expensive and inflexible Common Business Oriented Language (COBOL) mainframe systems. It's risky and difficult to add new business rules to these systems, so when regulations change, agencies have been forced to create manual workarounds. And many have developed complex business processes which the legacy systems don't support.

Agencies can solve these problems with modern technology, but they cannot risk interrupting the operation of mission critical systems, and they're working within strict budget constraints. What they need is an incremental approach that realizes immediate benefits while ensuring compatibility with future technologies.

Corticon BRMS helps users answer the legacy challenge with flexible deployment options. Agencies can combine it with an enterprise service bus (ESB), which bridges mainframe systems. Or they can integrate it with business process management (BPM) platforms or service oriented architectures (SOAs). Corticon can also easily retrieve data from existing relational databases.

In addition, Corticon externalizes the rules so users can update, validate and test business logic independent of other solution components. Non-technical domain experts can manage the rules without having to rely on IT to hard-code them. And business units can share rulesets to lower maintenance costs and ensure consistent policy compliance across the agency.

# SERVE CITIZENS BETTER WITH FAST RULE DEVELOPMENT

HHS agencies exist to serve their members and citizens; they have a responsibility to respond as quickly and consistently as possible, especially for vulnerable populations. But with older technology, they can get bogged down under high case volumes and manual processes. Some have a hard time ensuring consistency because there's little reporting available. Regulatory turmoil can overwhelm the people and the system.

Because subject matter experts (SMEs) can write and change business rules independently of IT, it's easy to react quickly to new regulations. With the detailed reporting capability, users can review historical outcomes to ensure consistency over time.

Operating within state and federal guidelines, HHS agencies must be ready for audits from the Centers for Medicaid and Medicare Services (CMS), and from state oversight committees. Agencies must defend citizen appeals as well. If they have little reporting available from older technologies and manual processes, these audits can drain time and energy out of the organization.

Users can also test new rules against historical data to ensure that changes do not cause unanticipated results.
